2. Rupa Rural Municipality invites electronic bids from eligible bidders for the procurement of Supply and delivery of HDPE pipe under National Competitive Bidding procedures.

5. Electronic bids must be submitted to the office Rupa Rural Municipality, Rupakot, Kaski, Nepal through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np) on or before 22-05-2019 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders representatives who choose to attend at 22-05-2019 13:00 hours at the office of Rupa Rural Municipality, Rupakot, Kaski, Nepal.  
Bids must be valid for a period of 90 of days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 240000.0NRs which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
